

Lambsfold Church & Faulkner Chevrolet

ELIGIBILITY:

You must be 18 years old or older to purchase a raffle ticket. Only (1) individual may be identified as the purchaser (or buyer/owner) of a raffle ticket. All federal, state and local laws and regulations apply. Void where prohibited. Tickets are \$40 each or two for \$75. Raffle tickets are not transferable. You must indicate your full name, address, phone number and email address on each raffle ticket purchased. Lambsfold Church, Faulkner Chevrolet, CASA of Titus, Camp and Morris Counties and its agents, board, vendors, volunteers and members assume no liability for lost, stolen, misdirected, mutilated, illegible, incomplete, undelivered tickets or tickets without proper payment received, which tickets shall be deemed invalid and shall be immediately disqualified. Current employees of Lambsfold Church and Faulkner Chevrolet and *their immediate family members RESIDING in their household* (spouse, parents, grandparents, children, or siblings) are not eligible to win. The benefiting Charitable Organization, CASA of Titus, Camp and Morris Counties Board and *their immediate family members RESIDING in their household* (spouse, parents, grandparents, children, or siblings) are not eligible to win. DRAWING:

Faulkner Chevrolet must receive all raffle ticket entries at 5:00pm (CST) on November 14, 2014. At that time the ability to purchase tickets will cease. Lambsfold Church and Faulkner Chevrolet reserves the right not to accept entries at their discretion.

RETURN AND CANCELLATION:

All purchases of raffle tickets are final and non refundable. The approximate retail value of the 2014 Chevy Cruze Eco is \$19,530. The Lambsfold Church and Faulkner Chevrolet Charitable Raffle winner is solely responsible for all state and local costs and charges including taxes, title, transfer fee, registration, and prize delivery. The 2014 Chevy Cruze will not be exchanged for money.

SELECTION AND NOTIFICATION OF WINNER:

Winner will be selected in a random drawing conducted at the Faulkner Chevrolet Dealership in Pittsburg, Texas on November 15, 2014 at 11:00am. All attempts to contact the Lambsfold Church and Faulkner Chevrolet ticket purchaser shall be made using the name, address, phone number, and email address provided. A second ticket will be drawn and serve as an alternate winner if after 14 calendar days the owner of the first ticket drawn does not claim the 2014 Chevy Cruze, or in case Lambsfold Church and Faulkner Chevrolet is unable to establish contact with said owner of the first ticket drawn.

The Lambsfold Church and Faulkner Chevrolet Charitable Raffle winner shall have 14 calendar days from notification of winning to claim the 2014 Chevy Cruze. If the selected winner is unable to be contacted or located after a 14-day period of calendar days from the drawing date, the 2014 Chevy Cruze will be awarded to the purchaser/owner of the alternate ticket drawn on original date of drawing. The 2014 Chevy Cruze winner, by entering, authorizes Lambsfold Church and Faulkner Chevrolet to publish their name and likeness on their website, in local news media, and in other promotional materials used for the raffle.
